1. Resolution #7, 2024 Adoption of New Personnel Manuals

Jenna Drook, Human Resources/Payroll Director, stated that these personnel manual updates were the first in almost six years; the department heads had gone through the handbooks with her and the mayor to ensure they reflect current policies. Reynolds asked Attorney Lehman if he had reviewed it and was told that there were no changes that would require a lawyer's input. Titus asked if each employee would receive a copy and acknowledge having read it. Chief Oswalt read the current verbiage of the acknowledgement page and Lehman agreed it was adequate. Department heads will be responsible for handing them out and collecting the acknowledgement pages. These handbooks will become effective at the first of the year. Titus motioned to approve Resolution #7, 2024. Reynolds seconded. Motion carried.

2. Bid Opening for Community Crossings Matching Grant

These bids are for the City's 50% matching portion of a grant received recently to work on Highland Drive, Parkway Drive, and Miami Street. Two bids were received:
